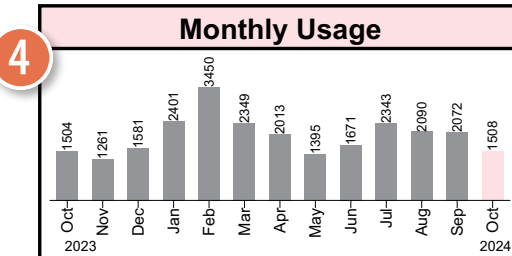

Explanation of bill

- 1 Account Information**
This section includes your account number, the total amount due and the due date for your bill.
- 2 Important Bill Message**
Please be sure to pay attention to this message each month. It contains event, program and other general information important to our consumer-members.
- 3 Electric Usage**
This table reflects—in kilowatt hours (kWh)—the amount of energy you used during the billing cycle. It also includes the number of days and exact dates of your billing cycle.
- 4 13-month Electric Usage**
This section shows members a 13-month history of their energy usage. It can help you review trends and evaluate the amount of energy you are using during specific times of the year.

- 5 Details of Charges**
 - a. Distribution Charge**
The distribution charge helps cover Warren RECC's cost to deliver power to the meter before any power is used, and it includes meters, poles, transformers, wires and service-related operating costs. This charge varies by rate class. It helps us keep pace with needed investments to improve both capacity and reliability.
 - b. kWh Charge**
This number is the total kilowatt hours you have used in this billing cycle multiplied by the price per kilowatt hour.
 - c. TVA Energy Fuel Cost**
TVA's Energy Fuel Cost, as Fuel Cost Adjustment (FCA), is determined by TVA on a monthly basis and covers the cost of the fuels that TVA uses to generate electricity at their natural gas, nuclear and coal power plants.
 - d. School Tax**
Warren RECC is required by the state of Kentucky to collect school tax based on the gross receipts from providing utility services in school districts within the state. Warren RECC collects 3% of gross receipts on utility services.
